In 2018, Hope cared for over 215 children, providing not just a loving home, but also a quality education in their state certified educational program. 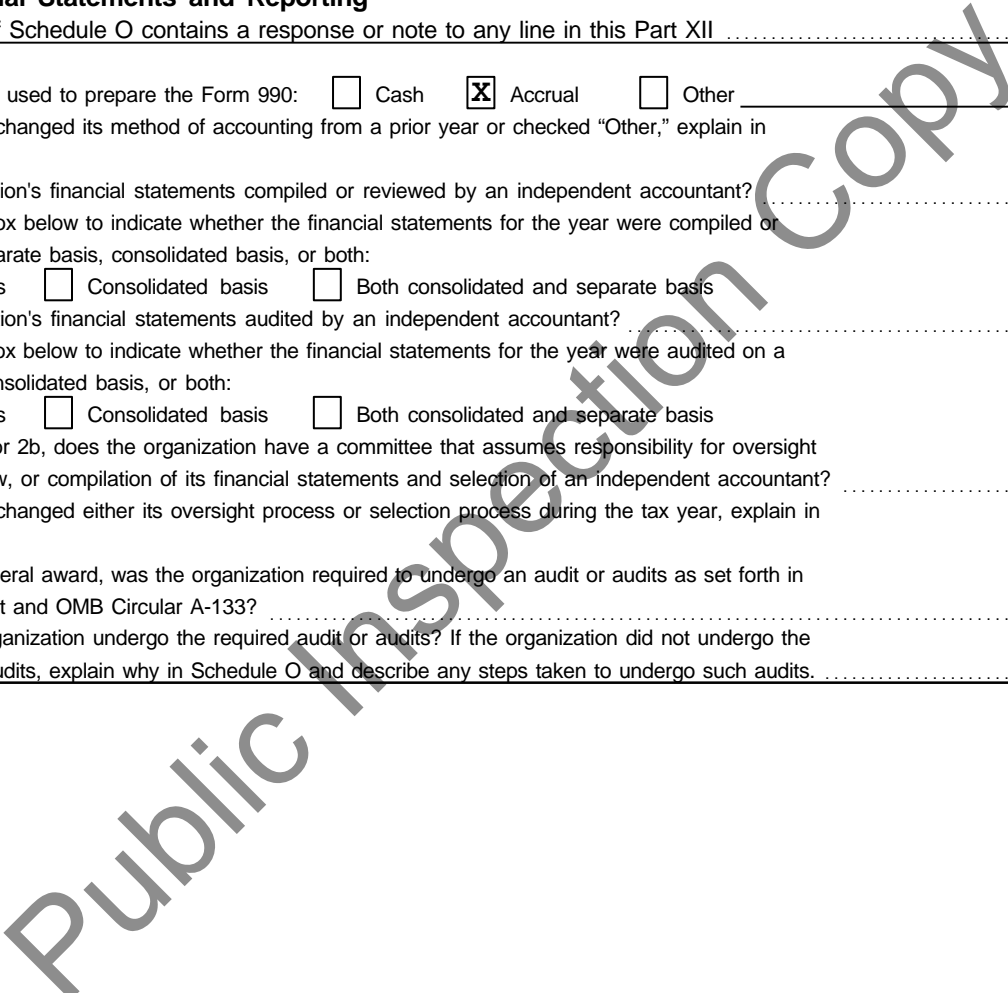

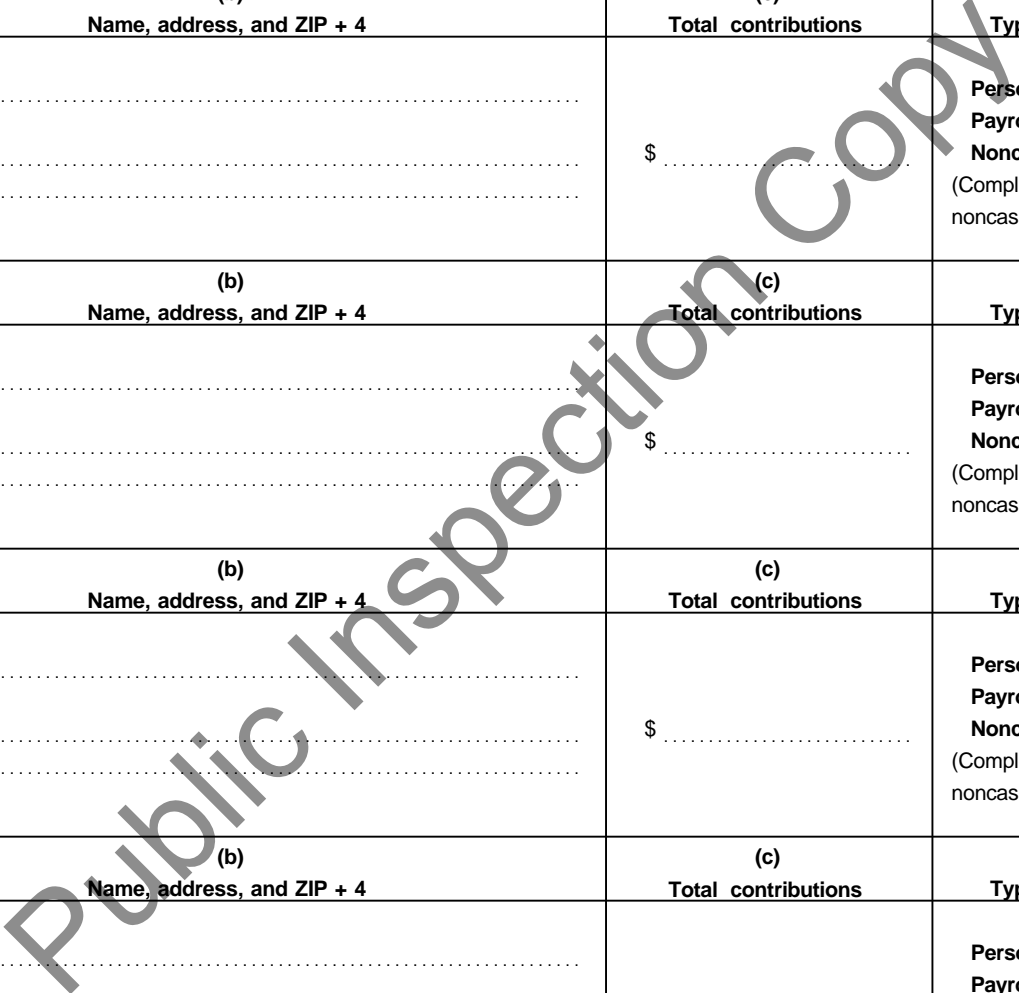

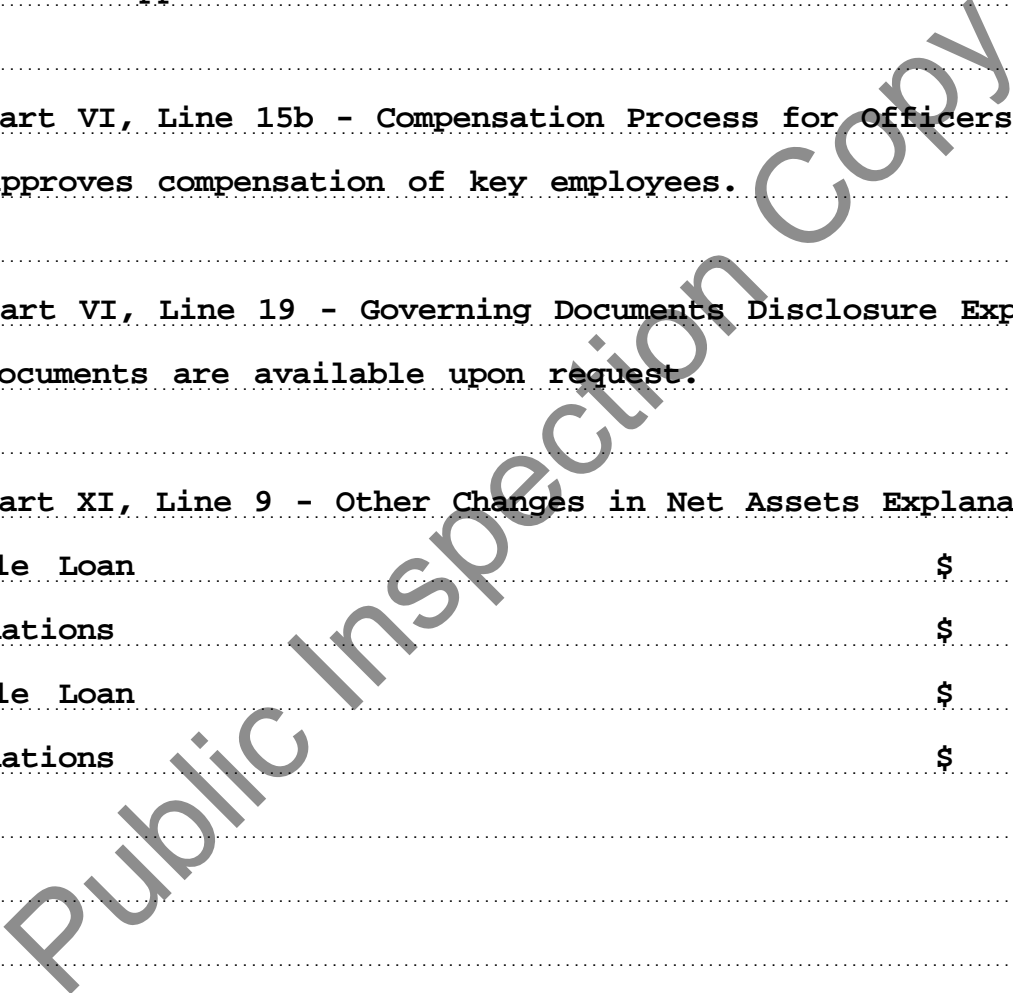
